Sub : Merger of ISO 9000/14001/HACCP certification scheme with ZED Certification scheme of O/o DC(MSME): reg.

Sir,

I am directed to inform that ISO 9000/14001/HACCP certification scheme of O/o DC(MSME) has been merged with ZED certification scheme under National Manufacturing Competitiveness Programme (NMCP) with the approval of competent authority. The guidelines of ZED certification scheme are likely to be issued shortly.

2. Therefore, all MSME-DIs are requested to inform/Publicize on their website about the merger of the scheme and not to receive fresh applications for reimbursement under ISO 9000/14001/HACCP certification reimbursement scheme on or after 01.07.2016.

3. Further, the applications already received in MSME-DIs upto 30.06.2016 under the ISO 9000/14001/HACCP certification reimbursement scheme are to be evaluated within 15 days' time i.e. 15.07.2016 as per the existing guidelines of the said scheme. Any discrepancy observed in applications may be got rectified by 31.07.2016. Thereafter, final list along with financial implications may be intimated in respect of eligible units as on 31.07.2016. The desired information may be forwarded to this office by 10.08.2016 for further releasing the sanction, subject to availability of budgetary provision during 2016-17 under the scheme.
